Application Guidelines

The Licensee will deposit with the Fort St. John International Air Show Society, at the time of application, the sum of Two Hundred Fifty Dollars (\$250.00) as security for the supply of services. The Licensee's Security Deposit may be a part of the Total Licensing Fee of \$300.00.

The Licensee will provide all materials required to perform the operation of the concession, inclusive of power, water, waste receptacles, tables, awnings, weights, and any other requirements to allow the concession to operate efficiently and safely during their time on the Airport apron. All materials are subject to approval by the Fort St. John Air Show Society and management team of the North Peace Regional Airport.



Upon application or prior to July 1, 2022 the Licensee shall:

- a. Provide written documentation of the Concession inspected by the appropriate government health unit and obtain from this health inspector a certificate of approval and provide the same to the Society and obtain such other licenses or permits as are required for the operation of a food service; and shall provide copies of all certificates and licenses to the Society. These include a valid business license and Food Safe certificates for all staff handling food.
- b. Provide proof of a current Comprehensive General Liability Policy with limits of not less than one million (\$1,000,000.00), inclusive of bodily injury and property damage for the term of this Agreement. This policy must contain Products and/or Completed and Contingent Employers Liability and will include additional insured wording:

“It is understood and agrees that coverage as provided under the above policy for Bodily Injury and/or Property Damage shall apply to:

The Fort St John International Air Show Society and North Peace Airport Services Ltd. as Additional Insured but only with respect to the operations of the Named Insured in connection with: (i.e.) operations of a concession stand at the North Peace Regional Airport, located at Fort St John, BC for the period of July 30-31, 2022.”

The Licensee will provide proof of liability insurance to the Society on or before July 1, 2022.

The Licensee will set-up the concession

- July 30, 2022 between the hours of 10:00 AM and 3:00 PM
- Vehicle removal and parked in designated area by 3:30 PM

The Licensee will operate the concession

- July 30, 2022 between the hours of 4:00 PM and 8:00 PM.
- July 31, 2022 between the hours of 11:00 AM and 4:30 PM.
- Tear down will commence at 4:30 PM and must be completed by Midnight, unless otherwise notified by the Society.

The Licensee will provide a detailed list of food products served during the event.

The Licensee will ONLY serve food products approved by the Society.

The Licensee will ensure that pricing is reflective of current market trends.



All concession requirements shall be the responsibility of the Licensee; additional material requirements will be for fee.

The Licensee will, prior to the commencement of the 2022 Fort St John International Airshow, obtain from the Society a written copy of a signed License for inspection by Airport Authority if requested.

The Licensee will be required to attend a food concession meeting to be held at such a time and place set by the Society and will abide by any rules and regulations set out at that meeting.

The Licensee will be responsible to keep the area immediately adjacent to the Concession free of litter at all times and will be responsible for disposing of such litter by placing it in garbage bags and placing the bags in a location specified by the Society.

The Licensee hereby declares that he/she is an independent contractor and he/she is solely responsible for all acts or omissions of persons who work in the concession. The Licensee agrees that it shall not hold itself out as representing the Society at any time and shall not contract or incur debt in the name of the Society.
